Goals of the Program:

The Bachelor Program in Social Sciences aims to provide its students both with broad (multidisciplinary) theoretical knowledge and diverse practical skills that enable them in future to function professionally within the field of social sciences and/or to continue their studies, deepen their knowledge and refine their skills at the next educational level.

As its organic component, the program offers to master one of three areas as an additional specialty (minor) - either in the sphere of public administration, or international relations, or psychology.

Based on the principles of Liberal Arts Education, the curriculum includes the following courses:

- Core/compulsory Courses (38 ECTS),
- Core/compulsory Courses of social sciences (120 ECTS), elective courses (24 ECTS), mandatory and elective courses of additional specialty (minor) (60 ECTS).

Goals of the Program:

The goal of the educational program is to provide students with:

- Broad theoretical knowledge of the main fields, concepts, theories, models and trends of social sciences;
- Broad knowledge of spiritual, artistic, philosophical and scientific heritage (outstanding examples of world literature, important events of world history, philosophical foundations of public thinking development, etc.), liberal values and basic principles of human rights.

The goal of the educational program is to provide students with:

- Skills to effectively apply in practice the gained theoretical knowledge;
- Capacity to conduct quantitative and qualitative small-scale empirical research, evaluate, analyze and present data and results;
- Critical thinking and logical reasoning skills;
- Effective communication skills - oral and written preparation/presentation of strong arguments, using information technologies (including including public presentations);
- Ability to work effectively both in a team and independently;
- Skills for successful promotion of democratic social values and professional ethics standards;
- Ability to efficiently respond to scientific innovations in the field of social sciences, the ability to constantly enrich knowledge and continue learning.

Preconditions for the admission to the program:

- Holder of the state certificate or an equivalent document, confirming completing the general education course.

- After successfully passing the following subjects: the Georgian Language and Literature; Mathematics, History or Geography and English as a foreign language (the results of the Unified National Exams)

At the same time, based on the existing legislation, it is possible the enrollment to the BA program without passing the Unified National Exams.

Enrollment is also possible through the mobility process, twice a year, in accordance with the Rule of Transfer, approved by the order N10/N of the Minister of Education and Science of Georgia dated February 4, 2010.

Enrollment in the educational program of Social Sciences, or transfer from a recognized higher educational institution of a foreign country, is carried out based on the decision of the Ministry of Education and Science of Georgia.

Social Science Program Learning Outcomes

Based on the goals of the bachelor's program in Social Sciences, the educational program aims to achieve the following six results:

Knowledge and awareness:

Learning outcome 1: Students define and describe the main directions, trends, fundamental theories, models and concepts of social sciences and its main sub-disciplines;

Learning outcome 2. – Students identify the social characteristics and challenges of literature, history, philosophy and geography on the basis of liberal values and basic humanrights, from the viewpoint of social sciences.

Skills

Learning outcome 3: Students compare and distinguish the main principles and characteristics of qualitative and quantitative research methodology, evaluates the current social phenomena in the world and in Georgia, based on the latest theoretical achievements in the field of social sciences;

Learning outcome 4: Students collect, organize and analyze information and prepare a small social science research paper, using social research methodology and design, in accordance with predetermined instructions and guidance;

Learning outcome 4: Students, using modern information technologies and following the field terminology of the social sciences, effectively communicate - both orally and in written with various representatives of professional and non-professional fields and, in a reasoned manner, analyze and evaluate the current challenges and prospects for the development of the field of social sciences.

Responsibility and autonomy:

Learning outcome 6: Students prepare academic paper in compliance with the norms of academic honesty and professional ethics and independently determine the needs for continuing education and deepening knowledge for their future professional development.

Academic personnel, depending on the task of a particular course, may use one or more of the abovementioned methods or any other method. The teaching-learning methods of a specific course are outlined in the syllabus of the relevant course.

Evaluation system for student knowledge:

The learning component of the Social Sciences Bachelor Program encompasses students' active participation in the teaching process and is based on the principle of continuous assessment of acquired knowledge.

Assessment of acquired knowledge on Social Sciences Bachelor Program is organized in accordance with the Order No. 3 by the Minister of Education and Science of Georgia, January 5th, 2007 - “The Rule of Calculation of Higher Education Program Credits”.

Evaluation of student’s learning results in each component of Social Sciences Bachelor Program includes mid-term (Onetime or Multiple) and summative evaluation, which is a result for final assessment (100 Points).

Mid-term and summative evaluations (Evaluation forms) include evaluation component/components, what determine ways to assess student’s knowledge and/or ability and/or competence (written/oral exam, written/oral quiz, homework, practical/theoretical work, etc.). Assessment component unites homogeneous assessment methods (test, essay, presentation, discussion, performance of theoretical/practical assignment, team work, participation in discussion, etc.). Assessment method/methods are measured by assessment criteria, by which achievement of learning outcomes is being measured.

Each assessment form and component have certain value allocated from the final score (100 Points), which is indicated in each Syllabus and is being communicated to each student in the beginning of the semester.

Credits should not be awarded by using only one form of evaluation (mid-term or summative evaluation).

Credits are awarded to the student only if he/she receives a positive assessment.

For admission of a student to the final exam in Social Sciences Bachelor program, 30% of the sum of intermediate grades is required (all types of grades except the final exam); the minimum threshold of competence for the final exam is 40%.

There are five types of positive assessment in the evaluation system:

- (A) Excellent –91-100 points of evaluation;
- (B) Very good –81-90 points of evaluation;
- (C) Good – 71-80 points of evaluation;
- (D) Satisfactory –61-70 points of evaluation;
- (E) Sufficient –51-60 points of evaluation.

And two types of negative evaluation:

- (Fx) Did not pass – 41-50 out of the maximum evaluation, which means that the student needs to work more to pass the exam and he/she shall be given the possibility to retake the exam after the self-study;
- (F) Fail – 40 points or less out of the maximum evaluation, which means that the work done by the student is not enough and he/she has to retake the course.

In case of (Fx) evaluation in any component of Social Sciences educational program, the University must hold an additional examination within not later than 5 days after the announcement of the results of the summative examination. The points, awarded to the student in the summative evaluation, shall not be added to the evaluation obtained by the student at the additional examination. The evaluation obtained by the student at the additional examination is the summative evaluation and shall be included in the final evaluation of the component of the educational program. In case of taking 0-50 points in the final evaluation, including the evaluation obtained at the additional examination, the student evaluation will be F-0 points.

The calculation of the Grade Point Average (GPA) is part of the system of evaluation of the student's knowledge. The student's Grade Point Average (GPA) is calculated by multiplying the evaluation, obtained by the student in every subject of the educational program, to the credits of that subject. The product of multiplication of the subjects and credits is summed up and divided by the total number of the credits of the taken subjects. The weight of the point in the calculation of the average number is:

- A = 4
- B = 3,2
- C = 2,4
- D = 1,6
- E = 0,8

Employment opportunities:

Graduates of the Social Sciences Bachelor program will be able to use the acquired knowledge in private and state, non-governmental and international organizations, where an appropriate qualification is required. The program provides sound theoretical knowledge as well as practical experience, which gives graduates the opportunity to start a successful career.

Opportunity for continuing education process:

Graduates of the Social Sciences Bachelor program are authorized to continue studies at Georgian or other countries' higher educational institutions at any MA programs if preconditions for the programs are not restricted by specific BA qualifications.

Human resources necessary for the program implementation:

The educational program of Social Sciences is provided by appropriate human resources. The educational components provided by the educational program are led by the academic staff of the university, as well as by the invited specialists with appropriate experience and competences.

Additional information on human resources is available in Appendix No. 2.

Material resources necessary for the program implementation:

The University infrastructure and material-technical resources are fully available for students to reach the learning outcomes of the Social Sciences program, in particular:

- Learning auditoriums and conference halls equipped with appropriate inventory;
- Library, equipped with computer hardware and informational-communicational technologies;
- Computer classes, computer hardware connected to internet and internal network and adequate computer software in learning/teaching process;
- Different technical equipment and et cetera.

The educational program is provided with appropriate manual and methodical literature. The University's library provides students with electronic textbooks relevant to the syllabus, educational-methodical and scientific literature, as well as the library's database and the electronic catalog posted on the university's website .

Material resources owned and possessed by the University, ensures the bachelor program of Social Sciences to implement its objectives and achieve planned learning outcomes.

Buildings and Structures - Educational bachelor program is carried out in the buildings and structures owned and leased by the university, where sanitary-hygienic and safety norms are highly respected (the buildings are equipped with installed alarms, fire extinguishers, video control system on the perimeter, order is maintained by the custodial servant of the university). The building is in full accordance with the technical requirements established for the institutions, lecturing and practicum auditoriums are equipped with relevant technique and inventory (projector, chairs, desks, boards and et cetera).

Library - In the library of the University the relevant printed and electronic fund of the bachelor's educational program is preserved, which is available for the students, invited and academic personnel. In the reading hall, students have the opportunity to use internet and international electronic resources (EBSCO; JSTOR; Cambridge Journals Online; Bio One Complete; e-Duke Journals Scholarly Collection; Edward Elgar Publishing Journals and Development Studies e-books; IMechE Journals; New England Journal of Medicine; Open-edition Journals; Royal Society Journals Collection; SAGE Premier). The library of the university has electronic catalogue.

Working Space of Academic Personnel - The working space of academic personnel is equipped with the relevant inventory and technical equipment (chairs, tables, wardrobes, computers with the access to internet, Xerox multifunctional machine).

Information and communication technologies - The University uses information and communication technologies in order to facilitate the implementation and administration of bachelor's educational program in Economics. There is a corresponding software for the bachelor's educational program in Economics, the existing computer hardware meets the contemporary requirements and is connected to the internet and is available for students, academic, invited and administration personnel. Electronic system – lmb.gipa.ge – is used for assessing student's knowledge and to coordinate teaching process. The system provides students with access to assessments, facilitates the control of academic attendance of students and the learning process in general. Through the webpage, which contains information about the educational programs and the learning process, the University provides publicity and accessibility of information.
